- **1. CALL TO ORDER:** Mayor Kennis Lutz called the meeting to order at 7:00 p.m. Mayor Lutz led the attendees in the Pledge of Allegiance.
- **2. ROLL CALL:** The roll call was conducted by Sharon Backus, Clerk/Treasurer. Council Present: Adam Farnsworth, Justin Fritz, Robert LaPier, Jeremiah Larsen and Mayor W. Kennis Lutz. A quorum of the Council was established.

## 3. ADOPT THE AGENDA:

Councilman Larsen moved to adopt the agenda. Councilman Fritz seconded the motion. There was no discussion. Vote: 5 Yes, 0 No, 0 Abstain, 0 Absent. Motion Carried.

## 4. APPROVAL OF CONSENT AGENDA:

#### 5. ACTION ITEMS/NEW BUSINESS:

 Request the Council to Adopt a Permanent Noxious Weed Ordinance for First Reading March 17, 2020 – Alpine Noxious Weed Advisory Committee (ANWAC): – Ms. Jan Hansen representative of the ANWAC addressed the council referencing 269 Ordinance No. 2019-06, an emergency ordinance adopted to regulate and eradicate noxious weeds in the Town of Alpine. Ms. Hansen stated that this emergency ordinance was now expired. The ANWAC is requesting that the Town of Alpine adopt a permanent ordinance

fashioned after the previous emergency ordinance and have it prepared for first reading on March 17, 2020.

Sharon Backus was directed to have the noxious weed ordinance prepared for first reading on March 17, 2020.

#### • Planning and Zoning Update – Rex Doornbos

Mr. Rex Doornbos of the Planning and Zoning Commission addressed the council and stated that there were four points he wished to make. The first is that Star Valley Health submitted a set of plans and are planning to come in for a building permit at the March commission meeting. Both Broulims and Star Valley Health have been great to work with and their plans are great.

Second, Melvin Brewing had a court date on Wednesday. Christine, Dan and I were there. The process went well. They plan to rectify the non-conforming structure by May 1<sup>st</sup>. The court set another court date, so Melvin Brewing is still under a timeline. They have indicated they want to fix the building permit. Mr. Doornbos stated that he had driven by last week and the pergola was roped off to prohibit access to the public.

Third, is a point brought up at the last meeting and that is updating the Alpine Master Plan. Mr. Doornbos asked if the council had a recommendation of a professional to draft or update the master plan. Mayor Lutz did not have a suggestion, but asked Karl Scherbel if he knew of a capable professional. Mr. Doornbos stressed the importance of this as he expects a "building explosion" in Alpine this summer.

Fourth, Broulims came in with a request for plat reviews. The one the council needs to act on tonight involves changes the water and sewer easements and Karl Scherbel has the Mylar with him. The Planning and Zoning Commission recommends the council approve the amended subdivision map.

#### Motion to Authorize Mayor Lutz to Sign Mylar of the Amended Subdivision Plat for Snake River Junction Fourth Filing per Planning and Zoning Commission Recommendation

Councilman LaPier moved to authorize Mayor Lutz to sign the Mylar of the Amended Subdivision Plat for Snake River Junction Fourth Filing per Planning and Zoning recommendation. Councilman Fritz seconded the motion. There was no discussion. Vote: Vote: 5 Yes, 0 No, 0 Abstain, 0 Absent. Motion Carried. The Mylar was signed by Mayor Lutz.

• Recommendation of Planning and Zoning Commission for Approval of the Minor Subdivision Application (Replat) for Broulim Addition (Snake River Junction) This item will be considered by the town council on March 17, 2020.

Mr. Doornbos stated that the commission also recommends the approval of the Minor Subdivision Application.

• Motion to Adopt 463 Resolution No. 02-18-2020 "Amend and Adopt in its entirety the Town of Alpine Policy and Procedure Manual". Sharon Backus, Clerk/Treasurer read 463 Resolution No. 02-18-2020 into the record.

Councilman Fritz moved to adopt 463 Resolution No. 02-18-2020 "Amend and Adopt in its entirety the Town of Alpine Policy and Procedure Manual" with the addition of "prohibition of using town owned vehicles and equipment for personal use". - Economic Development Update: Councilman Larsen gave the following report:
  - The Oyster Ridge Festival was approved on second reading;
  - Star Valley Media is working on a marketing package to promote Lincoln County and Star Valley focusing on tourism;

- The snowpack is great and numerous visitors have been in Star Valley to enjoy the snow;
- By way of caution, the bad news for the next two to three years is that the town will need to be ultra conservative on spending until a better income picture emerges and a clear path is foreseeable for the future.

Ms. Sarah Hale from the Chamber of Commerce announced that March 7, 2020 is "307 Day" for Wyoming Day so local establishments are asked to have something related to Wyoming to promote the day. More information will be released in the near future. In 2020 all the towns in Star Valley will be showcased with the project kicking off in May. Alpine will be showcased in August. It is hoped this will be conjunction with the Alpine Car Show.

Mayor Lutz stated that he had been approached to try to get Alpine's business park going with one or two new businesses. This is the property we purchased from Game and Fish with Business Council money with the intent of turning it into a business park. Mayor Lutz was asked how the town moves forward with development of this area. Mr. James Sanderson, Town Counsel stated that you cannot give or sell property without first advertising it. There is an exception if you have an Economic Development Board. So, the first step would be to establish an Economic Development Board (EDB) so the property can be transferred by the EDB rather than sold. The town could then approach the Wyoming Business Council for a Business Ready Grant for infrastructure funding. Mayor Lutz stated that it is hoped that this will turn into something positive. The town is growing so we need to get these things established. Mr. Sanderson stated that if this project was run through an EDB, it may be possible to adjust price based upon an entity putting in the infrastructure and streets.
