

TOWN OF ALPINE PUBLIC HEARING MINUTES LIQUOR LICENSE RENEWAL

Call to Order: Mayor Kennis Lutz called the Public Hearing to Order at 6:30 p.m.

Ms. Backus stated that this is the Public Hearing for renewal of ten liquor license applications. Between September 30, 2021 and October 4, 2021 the following individuals operating within the incorporated boundaries of the Town of Alpine submitted Renewal of Liquor License applications for the calendar year 2022:

The Town of Alpine published notice on the consecutive advertising dates of November 3, 2021 and November 10, 2021. All approved liquor license renewals will expire on December 31, 2022. Wyoming Liquor Division has certified approval for Driftwood Pizza LLC, Rocky Mountain Rogues Inc. and TI DAN Inc.

Wyoming Liquor Division has not certified approval of seven license applications as complete, those are Broulim's Supermarket, LLC; Broulim's Hardware LLC; Conrad and Bischoff Inc; La Cabana del Tequila LLC; Melvin Brewing Company LLC both Microbrewery and Restaurant Applications, and Yankee Doodles, LLC so is recommending the town table these seven licenses until the December 21, 2021 council meeting.

Ms. Backus asked for public comments, questions about or opposition to the liquor license renewals. There were no comments. Ms. Backus then stated that during the stated council meeting, two motions would be needed to deal with the liquor license renewal applications; one to approve qualifies renewals and a second to table the remaining unauthorized renewals.
