AN ORDINANCE REPEALING AND REPLACING 151 — ORDINANCE NO. 2007-07 TOWN OF ALPINE BUILDING DEPARTMENT FEE SCHEDULE FOR BUILDING APPLICATIONS AND PERMIT APPLICATIONS IN THE TOWN OF ALPINE AND 229 ORDINANCE NO. 2015-02 — LAND USE & DEVELOPMENT CODE, ARTICLE 2.2 GENERAL DEVELOPMENT REVIEW AND APPROVAL PROCESS, SECTION #2-208 — DEVELOPMENT FEES, SUB-SECTION (h), (i), (j) AND (k) AND ARTICLE 2.5 BUILDING DEVELOPMENT FEE SCHEDULE SECTION 2-501; SUB-SECTION (h), (i) AND (j). THIS ORDINANCE REPEALS AND REPLACES ANY AND ALL OTHER BUILDING FEE SCHEDULE ORDINANCES AND RESOLUTIONS. THIS ORDINANCE WILL ESTABLISH AN EFFECTIVE DATE AT ITS PASSING ON THE THIRD READING.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF ALPINE, LINCOLN COUNTY, WYOMING:

Section I: Building Department Fee Schedule

A. Permit/Application Type

Plan review by Town of Alpine building official is included in the base rate along with the required inspection fees, any additional inspections and/or re-inspections will be charged and/or billed to the property owner accordingly.

In addition to the permit fee (base rate and price per square foot) the town reserves the right with specific findings, to have a third party entity plan review conducted, at the expense of the applicant, this additional cost would be on any complex projects the town deems necessary.

Replating of subdivision applications shall start at the above costs. There may be extra costs incurred on case by case basis, as determined by the Town of Alpine, as every project will be different and may incur other/additional unforeseen costs.

Additional Fees

If any of the above fees do not fully cover the total costs of processing any application and/or additional inspections or re-inspections, additional fees will be assessed on a case by case basis, as determined by the Town Of Alpine Building Official and/or Staff.

Section II: Severability.

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate distinct and independent provision and such holding shall not affect the validity of the remaining portions of the ordinance.

SECTION III: Water and Sewer Connection Fees.

In conjunction with the permit building permit application process and before a building permit is issued, all water and sewer connection fees must be paid in full.

SECTION IV: Refunds/Waiver of Fees.

All fees are non-refundable. There will be no waiver of fees.

Section V: Ordinances Repealed.

All ordinances and parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

Section VI: Effective Date.

This Ordinance shall become effective from the date of its passage.
