# **TOWN OF ALPINE BUDGET FOR FISCAL YEAR 2021/2022**

AN ORDINANCE AMENDING THE TOWN OF ALPINE BUDGET FOR FISCAL YEAR 2021/2022 AS ADOPTED BY THE TOWN OF ALPINE ON JUNE 15, 2021.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF ALPINE, LINCOLN COUNTY, WYOMING THAT 278 ORDINANCE NO. 2021-01 TOWN OF ALPINE BUDGET WILL BE REPEALED AND REPLACED BY 291 ORDINANCE NO. 2022-09.
