433 RESOLUTION NO. 04-17-2018

A RESOLUTION IN FAVOR OF PLACING THE SPECIAL PURPOSE
EXCISE TAX ON THE NOVEMBER 2018 GENERAL ELECTION BALLOT
FOR THE FOLLOWING PROPOSITION:

Shall Lincoln County, Wyoming, be authorized to impose a one percent (1 pct.) Specific Purpose Sales and Use Tax within the County, the proceeds from which and the interest earned thereon to be used for funding the acquisition of land (if necessary), the planning, engineering, construction, remodeling, furnishing, equipping, and supplying, and, to the extent necessary and allowed by law, the payment of operation and maintenance, debt service, and/or lease payments, and, if necessary and/or available, to be used to leverage or match federal and/or state grant funds, in the following specified amounts and for the specified purposes provided below:

FOR THE TOWN OF AFTON: **\$1,851,112.00**
Street improvements on 3rd Ave (\$102,350), 4th Ave (\$302,498), 5th Ave (\$175,950), Lincoln St (\$93,150), Jackson St (\$201,718), Jefferson St (\$162,620), Madison St (\$589,145), Rulon Gardner Ave (\$114,097), and Hospital Lane (\$109,584).

FOR THE TOWN OF ALPINE: **\$1,500,000.00**
Reconstruct approximately one mile of Greys River Road, including repaving, curb, gutter, sidewalk, street lights, bus stops, and a separated pathway.

FOR THE TOWN OF COKEVILLE: **\$1,071,874.00**
1st North Waterline Replacement (\$220,442), Lagoon Road Sewer Rehabilitation (\$254,239), West Main Street Reconstruction (\$334,260), Fire Hydrant Replacement (\$129,809), and County Road 209 Sewer Rehabilitation (\$133,124).

FOR THE TOWN OF DIAMONDDVILLE: **\$2,153,814.00**
Mill and overlay on the following roads: McGovern, Burke, Keane, Glenco, Star, Sublet, Diamondville, Gomer, Susie, Lincoln, Hillcrest, Oakley, Twin Creek, and Radiant (\$2,131,514). Crack and chip seal on Gomer Street (\$22,300).

FOR THE CITY OF KEMMERER: **\$3,147,394.00**
Repave 5th West Avenue and repair sidewalks (\$467,412), repave Elk Street and repair sidewalks (\$614,607), repave Canyon Road south of Antelope (\$1,106,557), and reconstruct Dell Rio Drive west of Canyon Road (\$958,818).

FOR THE TOWN OF LABARGE:

\$515,419.00

Chip seal all municipal roads

FOR THE TOWN OF OPAL:

\$400,000.00

Scoping and cleaning sewer line (\$100,000); repair or replace town backhoe, grader, salt/sand spreader, dump truck, and F-150 (\$100,000); street upgrades on unpaved roads for South Front Street, Whitetail, Wapiti, Mule Deer, Fox, Coyote, Bobcat, Big Horn, Antelope, Chrisman, and Solliday streets (\$200,000).

FOR THE TOWN OF STAR VALLEY RANCH:

\$1,265,879.00

Chip seal 15.12 miles of road within town boundaries including Alpine, Aztec, Barberry, Bear Lake, Bingham, Bonneville, Brambleberry, Brushwood, Butte, Cedar Creek, Chokecherry, Custer, Dogwood, East Street, Hardman, Holly, Last Chance, Lilac, Mahogany, Middle Branch, Piute, Ponderosa, Porto, Prater, Sage, Scrub Oak, Tumbleweed, Vista East, Vista West, West Elkhorn, and West Street.

FOR THE TOWN OF THAYNE:

\$550,000.00

Pave Community Center parking lot (\$125,000); reconstruct Van Noy Parkway (\$425,000).

GRAND TOTAL FOR PROJECTS IN LINCOLN COUNTY: \$12,455,492.00

WHEREAS, W.S. Section 39-15-204(a)(iii) (as amended) authorizes Lincoln County to impose an excise tax not to exceed two percent (2%) upon the sales of tangible personal property, admissions and services made within the county; and,

WHEREAS, the revenue from the tax shall be used in a specified amount for specific purposes authorized by the qualified voters; and,

WHEREAS, W.S. Section 39-15-203(a)(i) (as amended) stipulates that no such tax may be imposed until the proposition to impose the tax is submitted to the vote of the qualified electors of Lincoln County and a majority of those casting their ballots have voted in favor of imposing the tax; and,

WHEREAS, W.S. Section 39-15-203 (a)(i)(B) provides that the proposition to impose an excise tax shall be submitted to the electors of the county upon the receipt by the board of county commissioners of a resolution approving the proposition from the governing body of the county and the governing bodies of at least two-thirds (2/3) of the incorporated municipalities within the county; and,

WHEREAS, the Governing Bodies of the towns of Afton, Alpine, Cokeville, Diamondville, Labarge, Opal, Star Valley Ranch, and Thayne, and the City Council of the City of Kemmerer, desire that voters be allowed to consider a proposition to impose a one percent (1%) tax for specific purposes within Lincoln County on the ballot before the voters of Lincoln County; and,

WHEREAS, the Governing Bodies of these municipalities encourage the board of county commissioners of Lincoln County to approve a resolution in favor of placing a question regarding the imposition of a one percent (1%) tax for specific purposes within Lincoln County on the ballot before the voters of Lincoln County.

NOW, THEREFORE, BE IT RESOLVED by the Governing Bodies of Afton, Alpine, Cokeville, Diamondville, Kemmerer, LaBarge, Opal, Star Valley Ranch, and Thayne, Lincoln County, Wyoming, that the Board of Commissioners of Lincoln County, Wyoming, be and are hereby notified pursuant to W.S. 39-15-203(a)(i) (as amended) of the resolution of these Governing Bodies approving the submission to the voters of Lincoln County at the 2018 general election, the proposition of whether a one percent (1%) excise tax on tangible personal property, admissions and services obtained within Lincoln County be imposed for specific purposes.

BE IT FURTHER RESOLVED that these Governing Bodies encourage the Board of Commissioners of Lincoln County, Wyoming to also approve a resolution to place a one percent (1%) excise tax on tangible personal property, admissions and service obtained within Lincoln County for specific purposes designated by local governments on the ballot before the voters of Lincoln County at the 2018 general election.
