

TOWN OF ALPINE PUBLIC HEARING MINUTES LIQUOR LICENSE RENEWAL

Mayor Lutz welcomed those in attendance and stated that this Public Hearing is to give the public an opportunity to discuss a Liquor License Renewal. Mayor Lutz asked Ms. Sharon Backus, Clerk/Treasurer to conduct the Public Hearing.

Open for public comments:

Ms. Backus stated that this is the Public Hearing for renewal of the Conrad and Bischoff, LLC County Malt Beverage Permit. On November 15, 2021, Michelle Andressen and Danny Armstrong as Conrad and Bischoff LLC, d.b.a. KJ'S Alpine, an entity operating within the incorporated boundaries of the Town of Alpine, submitted a Renewal of Liquor License Application for the Calendar year 2022 for a County Malt Beverage Permit.

The Town of Alpine published notice on the consecutive advertising dates of November 24, 2021 and December 1, 2021. If approved, the County Malt Beverage Permit will expire on December 31, 2022. Wyoming Liquor Division has certified the application complete.

Ms. Backus asked for public comments, questions about or opposition to the liquor license renewals. There were no comments. Ms. Backus then stated that there being objections, she recommends approval of this license during the Council Meeting.
